## 1. Aims

The aims of relationships and sex education (RSE) at our school are to:

- > Provide a framework in which sensitive discussions can take place
- > Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- > Help pupils develop feelings of self-respect, confidence and empathy
- > Create a positive culture around issues of sexuality and relationships
- > Teach pupils the correct vocabulary to describe themselves and their bodies

We see these aims fully compatible with our ethos:

'We aim to prepare young people for re-integration by identifying their individual curriculum requirements and supporting their personal, social, health and emotional needs within a safe and nurturing environment.'

# 2. Statutory requirements

Under <u>section 3.6 of the National Curriculum</u>, RSE is compulsory from year 7 onwards.

Secondary schools must have regard to <u>guidance</u> issued by the secretary of state as outlined in section 403 of the <u>Education Act 1996</u>. Further advice and guidance is to be found in <u>Relationships Education</u>, <u>Relationships and Sex Education (RSE) and Health Education (DfE, 2019)</u>. In light of the recent concerns around 'peer on peer' abuse it is particularly important to read the <u>safeguarding, reports of abuse and confidentiality</u> section of the statutory guidance and you may want to look at the other <u>information and resources</u> provided by the DfE.

# 3. Policy development

This policy has been developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

- 1. Review a member of staff or working group pulled together all relevant information including relevant national and local guidance
- Staff consultation all school staff were given the opportunity to look at the policy and make recommendations
- 3. Parent/stakeholder consultation parents and any interested parties were invited to submit comments about the policy which was available to them on our web-site.
- 4. Pupil consultation we investigated what exactly pupils want from their RSE
- 5. Ratification once amendments were made, the policy was shared with Management Committee members and ratified

## 4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information, and exploring issues and values.

RSE is not about the promotion of sexual activity.

## 5. Curriculum

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary.

We have developed the curriculum in consultation with parents, pupils and staff, taking into account the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online.

# 6. Delivery of RSE

- The unit group programme as well as programmes to devised by 'home schools' to support individuals including those with Special Educational Needs.
- The ASDAN Key Steps and various subjects as identified in our PSHE policy.
- The Poplar Adolescent Unit (Education) ethos.
- PSHE Association Programme of Study Key stages 1-5.
- Small group sexual health sessions delivered by Brook or Virgin Care.
- Whole unit pathways in partnership with outside agencies to provide services for YP for such issues as contraception and STIs.
- RSE is taught within the personal, social, health and economic (PSHE) education curriculum. Biological
  aspects of RSE are taught within the science curriculum, and other aspects are included in beliefs and
  values which included different religious views.
- Pupils also receive stand-alone sex education sessions delivered by a trained health professional.

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- > Families
- > Respectful relationships, including friendships
- > Online and media
- > Being safe
- > Intimate and sexual relationships, including sexual health

### SPECIFICALLY WE RECOGNISE

- Youngsters will come from a variety of backgrounds, some of which may make this subject both distressing and difficult.
- Equally, some backgrounds may not mirror the values or experiences expressed in the range of programmes.
- Staff need to be sensitive to the needs of all youngsters, taking account of their differing stages of maturity and protecting their sensibilities.
- Information should be presented objectively, sensitively, within a framework of values, showing due regard to law on sexual behaviour and acknowledging moral, religious and ethical issues.
- Youngsters should be encouraged to develop skills of self-restraint, dignity, respect for self and others, responsibility and sensitivity towards other's needs and views.
- Stress will be placed on the process of human reproduction as being part of a loving relationship.
- 'Teasing' or bullying on sexual matters will not be tolerated and may be considered as 'peer on peer' abuse.
- Intense relationships are not permitted on the unit.

#### **EQUAL OPPORTUNITIES**

This policy is in line with the Local Authority's policies and procedures on Equality and Diversity. The Unit's Disability and Equality Policy states its commitment to:

'Advance equality of opportunity between people who share a protected characteristic and people who do not.'

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

# 7. Roles and responsibilities

## 7.1 The Management Committee

The Management Committee will approve the RSE policy, and hold the Executive Head to account for its implementation.

#### 7.2 The Executive Head

The Executive Head is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from non-statutory components of RSE (see section 8).

#### 7.3 Staff

Staff are responsible for:

- > Delivering RSE in a sensitive way
- > Modelling positive attitudes to RSE
- > Monitoring progress
- > Responding to the needs of individual pupils
- > Responding appropriately to pupils whose parents wish them to be withdrawn from the non-statutory components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the Executive Head.

Kathy Johns, teacher, is responsible for teaching RSE in our school.

## 7.4 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

# 8. Parents' right to withdraw

Parents have the right to withdraw their children from the non-statutory components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing and addressed to the Executive Head. A copy of withdrawal requests will be placed in the pupil's educational record. The Executive Head will discuss the request with parents and take appropriate action.

Alternative work will be given to pupils who are withdrawn from sex education.

# 9. Training

Staff are trained on the delivery of RSE as part of their induction and it is included in our continuing professional development calendar.

The PSHE co-ordinator organises a regular timetable (half-termly) of visitors from outside the school, such as school nurses or sexual health professionals, to provide teaching sessions to the young people. Currently 'Brook' is our provider and we are investigating support and training from them to our staff teaching RSE.

# 10. Monitoring arrangements

The delivery of RSE is monitored by Steph Yates, Executive Head through staff reports and scrutiny, learning walks, etc.

Pupils' development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by Steph Yates, Executive Head every 4 years. At every review, the policy will be approved by the Management Committee.

Appendix 1: By the end of secondary school pupils should know

This includes different (non-sexual) types of relationship

	<ul> <li>How stereotypes, in particular stereotypes based on sex, gender, race, religion, sexual orientation or disability, can cause damage (e.g. how they might normalise non- consensual behaviour or encourage prejudice)</li> </ul>

	<ul> <li>Not to provide material to others that they would not want shared further and not to share personal material which is sent to them</li> </ul>
	<ul> <li>What to do and where to get support to report material or manage issues online</li> <li>The impact of viewing harmful content</li> </ul>
	That specifically sexually explicit material e.g. pornography presents a distorted picture of sexual behaviours, can damage the way people see themselves in relation to others and negatively affect how they behave towards sexual partners
	That sharing and viewing indecent images of children (including those created by children) is a criminal offence which carries severe penalties including jail
	How information and data is generated, collected, shared and used online

	The facts about reproductive health, including fertility and the potential impact of lifestyle on fertility for men and women
	That there are a range of strategies for identifying and managing sexual pressure, including understanding peer pressure, resisting pressure and not pressurising others
	That they have a choice to delay sex or to enjoy intimacy without sex
	The facts about the full range of contraceptive choices, efficacy and options available  The facts about the full range of contraceptive choices, efficacy and options available.
	The facts around pregnancy including miscarriage  That there are choices in relation to prognancy (with modically and logally accurate).

	How the use of alcohol and drugs can lead to risky sexual behaviour
	How to get further advice, including how and where to access confidential sexual and reproductive health advice and treatment
